



DIRECTIONS

(can also be found on our website)

To: 4016 Rock Hall Rd, Point of Rocks MD

From East or West:

I-70 or I-270 to Frederick MD. Take Exit 52 US 15 South/US340 West. Follow US 15 South to just before the Potomac River (US/MD state lines). At the traffic light (Clay St/Rt 28), just before the bridge, turn left onto MD Rt 28—Point of Rocks. Proceed ** 0.8 miles on Rt 28, cross railroad tracks and immediately turn right onto Rock Hall Road, then left into the parking area for the Catoctin Kennel Club Training Facility.

From PA and North:

Follow US 15 South to Point of Rocks. Proceed ** as above

From Northern VA:

Follow US 15 North to Potomac River, cross bridge and make an immediate right onto MD Rt 28. Proceed ** as above.

NOTICE TO EXHIBITORS/ATTENDEES

- Crates + Grooming Tables if space allows; NO Xpens
- Professional handlers may only show their own dogs.
- Champions of record may only be shown in Jr Showmanship.
- Should the match be cancelled for any reason (can't hold on the original dates or contingency dates), no refunds will be given.
- Anyone observed not cleaning up after their dog(s), on the match grounds or in building, will have their entry excused with no refund.
- No flexileads and no prong collars allowed.
- Dogs must be shown according to AKC rules. No taped ears, no foreign substances, etc.
- All dogs present must be on a leash or confined to a crate when not being judged.
- Children, except when exhibiting in the ring, must be accompanied by a parent/guardian while on the match grounds or in the building.
- Unentered dogs are not allowed on the match grounds or in the building.



CLASSES

Conformation classes: Divided by sex

Puppy: 3-6mos, 6-9mos, 9-12mos

Adult Classes for dogs over 1yr of age: Novice OR Open

Puppies and Adults will not compete with each other.

For Exhibition Only (FOE): Class in any age group

**Dogs with a major win may only compete in FOE or
as a Jr Showmanship dog**

For FOE: Regular Entry Fee applies; no placements & no ribbons given out

Junior Showmanship Classes: (Jrs may enter both days)

Novice OR Open: 8 through 11 years

Novice OR Open: 12 through 14 years

Novice OR Open: 15 through 17 years

ENTRY FEES

\$8 per dog, with \$5 for additional entry of same dog

**Junior Showmanship is FREE if dog is entered in another
class, otherwise, the cost is \$5**

Pre-entry Available—deadline 1/20/09

Pre-entry: \$6 per dog, each addtl entry of same dog is \$5

No confirmation of Pre-entry receipt will be sent.
